Level of Effort: Location: **Consultant to Develop Corruption Risk Index on Government Procurement** 40 days lakarta

BACKGROUND

Kemitraan bagi Pembaruan Tata Pemerintahan (KEMITRAAN) is a multi-stakeholder organization established to promote governance reform. It works hand-in-hand with government agencies, CSOs, the private sector, and international development partners in Indonesia to bring about reform at both the national and local levels. KEMITRAAN builds crucial links between all levels of government and civil society to sustainably promote good governance in Indonesia. Since our inception in 2000, KEMITRAAN has established a wide range of multi-stakeholder networks at all levels. We work together with the government in mainstreaming good governance principles in public policy making, implementation and monitoring phases with evidence-based approaches.

Awarded on January 10, 2022, the Indonesian Integrity Initiative (INTEGRITAS) is a five-year program funded by USAID/Indonesia and implemented by KEMITRAAN, in collaboration with Indonesia Corruption Watch (ICW), Transparency International-Indonesia, and the Basel Institute on Governance, and in partnership with Indonesian civil society organizations (CSOs) and government agencies.

The goal of INTEGRITAS is to support the Government of Indonesia (GOI) in its corruption prevention efforts through enhancing civic engagement and strengthening a culture of integrity for both the public and private sectors. INTEGRITAS seeks to enhance Indonesian civil society capacity and role to more effectively partner with and support key GOI oversight institutions, while simultaneously ensuring sufficient preventative and oversight mechanisms are in place in the public and private sector.

The activity will cooperate and work with government and non-government key actors to achieve this goal through two interrelated intermediate results (IRs):

- IR I: Implementation of transparent policies and practices that reduce conflicts of interest (COIs) increased.
- IR 2: Public education on, awareness of, and participation in anti-corruption efforts improved.

The government procurement sector is still a thriving field for corrupt practices in Indonesia. Based on KPK data as of January 10, 2024, corruption in the procurement of goods/services is still the second largest corruption case after gratification/bribery. In the period 2004-2022, KPK has handled 1,351 corruption cases, of which around 277 cases (20%) occurred in the field of goods/services procurement.¹

As one of corruption prevention efforts in the public procurement area, in December 2023 KEMITRAAN and Lembaga Kebijakan Pengadaan Barang/Jasa Pemerintah (LKPP) signed MoU of collaboration to strengthen the transparency on public procurement. One of the activities is to support LKPP to develop a corruption risk index. This index aims to help the government in analyzing the risk area of corruption in public procurement.

Following that, KEMITRAAN is seeking applications from qualified consultants with extensive experience in developing index in the anti-corruption area and having great knowledge and experience in public procurement will be preferred. The detailed tasks are listed under the sections of this document on Expected Outputs (Activities, Services and Work) / "Scope of Work". Applicants whose application is determined to be within the competitive range may be contacted to answer additional questions, provide clarification, and/or present their applications after the applications submission deadline.

OBJECTIVES

The development of corruption risk index in public procurement aims to support the government to 1) analyze the corruption risk assessment during the public procurement; 2) improving the transparency and accountability in public procurement; 3) encouraging the growth culture of integrity in public procurement; and 4) indicate the quality of government procurement governance.

SCOPE OF WORK

Outputs

The consultant will produce the following deliverables:

- 1. Conceptual framework of the corruption risk index on government procurement;
- 2. The instrument of corruption risk index on government procurement;
- 3. The implementation guideline of the corruption risk index on government procurement.

Duties and Responsibilities

KEMITRAAN and LKPP seek a consultant to develop a corruption risk index on public procurement. Tasks are expected to include, but are not limited to, the following:

- 1. Develop the design of the conceptual framework including the methodology of the corruption risk index in public procurement;
- 2. Develop and finalize the corruption risk index on public procurement, which will be implemented to the government institution in national and sub-national levels;

- 3. Develop the implementation guideline of the corruption risk index in public procurement including the methodology, interpretation, and sustainability of the index;
- 4. In coordination with KEMITRAAN and LKPP, he/she will lead the process of expert meeting and Focus Group Discussion with related stakeholders;
- 5. Facilitate consultative discussion with various related stakeholders;
- 6. Develop an executive summary both in Bahasa and English;
- 7. Lead the process of try-out the instrument of the corruption risk index on public procurement;
- 8. Develop and present the instrument's try-out result to KEMITRAAN and LKPP

Intended Audience

The corruption risk index in public procurement will be implemented to the government institutions both at national and sub-national levels (province and city/district).

Source of Data

The data can be obtained from several sources such as the integrity survey (Survei Penilaian Integritas/SPI) from KPK and the data of government procurement from LKPP.

Review Process

The product will be reviewed by KEMITRAAN and LKPP team.

COMPETENCIES AND QUALIFICATIONS

The consultant will be selected through a competitive recruitment process. The consultant must have the following qualifications:

- 1. Minimum a master's degree (S2) or bachelor's degree with more than 10 years of experience in the anti-corruption issues, law, public policy, public administration or other related fields;
- 2. At least 10 years of experience in developing index in the anti-corruption issues;
- 3. Experience working in government procurement is preferable;
- 4. Great knowledge on good governance and its implementation;
- 5. Demonstrated experience in working with government institutions both at national and sub-national levels on anti-corruption and procurement issues;
- 6. Excellent skill on workshop facilitation and stakeholder engagements;
- 7. Superior ability to produce high-quality reports both in Bahasa Indonesia and English;
